SHIPYARD REIMERSWAAL ENVIRONMENTAL STATEMENT

It is the policy of Shipyard Reimerswaal to build, repair, convert and modify ships, and to conduct related dock activities in a safe, healthy and environmentally responsible way. The Environmental policy is part of the overall company policy, but also as a sub-policy it is inextricably linked to all aspects of the business and is carried out with the same commitment as the realisation of other business objectives.

Environmental business objectives of Shipyard Reimerswaal

Shipyard Reimerswaal wants to know, manage and minimise the effect (as low as reasonable achievable) on the environment caused by their activities, with ultimate goals:

- Zero environmental incidents.
- Work is carried out within the legal boundaries as set in the environmental permit.
- Achieve reduction of CO₂ emission of the yard by approx. 5% in the year 2025.
- Achieve reduction of CO₂ emission of the yard by approx. 10% in the year 2030.
- Achieve reduction of CO₂ emission of the yard by approx. 13% in the year 2035.

Mentioned goals can only be achieved when the managing board, employees, temporary workers and third parties are familiar with this Environmental policy and take responsibility for it. Annually this Environmental policy will be reviewed and adapted if required.

OUR LEGAL RESPONSIBILITIES REGARDING ENVIRONMENT

Shipyard Reimerswaal is by law responsible for the implementation of the below mentioned environmental responsibilities as embedded in the prevailing environmental permit :

3 main top-down responsibilities

(management, supervisory personnel):

1. Create and maintain an environmental safe workplace;
2. Provide instructions & training on environmental issues;
3. Supervise & correct.

3 main bottom-up responsibilities

(all employees & sub-contractors):

1. Follow procedures & instructions;
2. Report environmental hazardous situations;
3. Stop work when in direct environmental danger.

PRINCIPLES & REQUIREMENTS

This policy has been set up to prevent environmental accidents. When accidents occur they should be dealt with in an adequate way.

Law and regulations regarding environmental requirements are known, reviewed and will be complied with.

Environmental aspects are considered in the selection of suppliers and subcontractors.

Encourage customers to follow SWR's environmental policy when they visit the yard.

All employees are actively involved in the Environmental policy by instruction and training.

We are prepared to identify and react on environmental spills on order to stop and minimise the effect.

We encourage our employees, clients and third parties to report situations which (may) have a significant effect on the environment.
